

## Lathkill Dale Area Index

### Foreword:

This index is intended to provide a reference to the existence and location of all sites of interest in the area including where known, current access information. If you can provide any further information, highlight an omission or an error please contact [caveguides@peakdistrictcaving.info](mailto:caveguides@peakdistrictcaving.info). All significant updates are passed on the DCA. Detailed guides to each of the major caves in the area are in the pipeline and will be published on-line as part of the Peak District Caving Micro Guide series.

### The area:

The Lathkill Dale / Monyash Basin hydrological catchment area is often overlooked in general caving circles, but it is home to some significant caves. For the sport caver they provide some hard and rewarding trips, and for the explorer, some of the best potential for new cave, which will inevitably be hard won. Classic trips in the area include Lathkill Head Cave, which although usually flooded, provides an excellent through trip during prolonged dry weather. The extensive Knotlow and Hillocks systems are part mine, part cave, varied and sporting. Water Iclide Close Cavern, although not particularly long, contains large high level fossil phreatic passages and major potential for further exploration.

### Calesdale New Cave

Grid Ref: SK 17360 65372 (GPS), Alt: 214m. Length: 18m.

**Description:** Hidden in the undergrowth almost opposite Lower Calesdale Cave, a flat out oval passage becomes too tight after 18m. There is evidence of badger occupation, grrrrrr.

### Critchlow Cave

Access: The entrance is next to the Lathkill Dale public footpath, but be aware it is within a National Nature Reserve. An agreement has been drawn up between the Derbyshire Caving Association and English Nature. Basically, no prior permission is required, but:- all lights must be electric (i.e. no Carbide) and all visitors must be affiliated in one way or another to the National Caving Association, and the rest is just common sense.

**Description:** An extremely arduous flat-out cave with numerous restrictions and obstacles. Sections become impassable in wet weather and in flood a stream resurges from the entrance.

Access:-

- **The Resurgence:** This entrance is next to the Lathkill Dale public footpath, but be aware it is within a National Nature Reserve. An agreement has been drawn up between the Derbyshire Caving Association and Natural England (English Nature as was). No prior permission is required, but... all lights must be electric (i.e. no Carbide) and all visitors must be affiliated in one way or another to the National Caving Association, and the rest is just common sense.
- **Top Entrance:** No prior permission required but the agreement between DCA, Chatsworth Estates and Natural England (English Nature as was) must be adhered to:
  - 1). Access is limited to members of DCA or to members of NCA member clubs who must also be able to produce evidence that they hold a current Public Liability Insurance.
  - 2). The prescribed route to the cave must be followed: Follow the public footpath from Lathkill Dale to One Ash Grange; Leave the footpath at a point just north of the 4-wall junction with two cattle troughs at SK 16595 65867, go through the gateway over to the left (E) and head diagonally NE across the field to the obvious gateway by the wall junction; Go through the gate and then follow the wall north to the entrance.
  - 3). The lid on the shaft requires a large adjustable spanner to undo the bolt and it must be bolted shut from below once you are down the shaft. (The bolt can be undone from either above or below at all times.)
  - 4). Cavers must comply with the NCA Minimal Impact Caving Code - also maximum party size is 6 and minimum is 3.
  - 5). A log book is kept inside the cave at the top of the shaft and cavers are asked to sign in on entry.
  - 6). The cave is within the newly redrawn boundaries of the Lathkill Dale SSSI and National Nature Reserve. All digging activity in the cave must be approved by Natural England.
- **The Garden Path:** This entrance is gated and locked on the instruction of the landowners (Chatsworth Estates). This is covered by a different

A 24mm or large adjustable spanner is required to open the gate on the adit / incline entrance.

There is a gate, just inside the entrance, for which you will need a large adjustable spanner. The gate should be secured behind you, both on the way in and on the way out.

## Water Icicle Close Cavern

Grid Ref: SK 16105 64580 (CAP) Alt: 339m.

Length: 218m, Vertical Range: 40m.

Access: No known restrictions. Park at the end of Derby Lane taking care not to block any of the gates. Derby Lane can get rutted in places, especially after wet weather.

**Description:** A fine 32m deep mine shaft lands in a chamber at the junction of three large passages. The **North Passage** soon lowers to stooping then crawling in squalid mud terminating in a dig. The **South Passage** soon reaches a large rift modified by mining. Just prior to the rift a small crawl at floor level on the right is **Batty Farber Passage** which closes down after 8m. The **North West Passage** is over 100m long and is predominantly easy going along an impressive fossil phreatic passage up to 3m in diameter. It ends at a breakdown chamber which has been the focus of a number of digging projects. This is one of the most promising sites in the area but as yet no one has managed to find the way on through the choke.
